## **Board Members Continue to Improve the Buildings and Landscape**

During the past five years, the board has added or completed the following improvements to the buildings or the campus:

- Added patio awning and patio extension at Trinity Pointe
- Planted several new trees and replaced several lost to the derecho
- Improved the landscaping at Moundview Manor and Scott Meadows
- Purchased new community room furniture for Trinity Pointe and Moundview Meadows
- Repaired the driveway at Trinity Pointe
- Repaired sidewalk trip hazards at all three buildings
- Added a walking trail on the campus
- Added planters for resident use at all three buildings
- Purchased safety shower chairs
- Converted tubs at Moundview Manor and Scott Meadows to walk-in showers
- Upgraded all the computers including digital hard drives
- Repaired the brick exterior at Trinity Pointe
- Changed the lighting in the parking lots to LED lighting
- Purchased new washers and dryers
- Added coin changers at all three buildings
- Increased the size of the parking lot at Moundview Manor
- Improved the property reserved for a fourth building
- Added new secure entry systems at all three buildings
- Installed security cameras
- Upgraded the elevator at Moundview Manor
- Added an evergreen sound barrier at Moundview Manor
- Purchased new signage for the buildings and the campus
- Painted the interior community areas at Trinity Pointe and Moundview Manor
- Annually solicited and delivered gift cards from churches and delivered gift bags

The rental receipts generally are designed to pay for the upkeep of the three buildings. However, the board has applied for and received grant funding to pay for additional repairs and to add improvements to the buildings and campus. Donations and fundraisers also fund enhancements such as those described above. Thank you for your generosity and support.

### **Supporting Churches Continue to Help**

The supporting churches have donated \$20,000 to MSLC to support the needs of the residents. This is in addition to the thousands of dollars in gift cards given by church members as Christmas gifts for residents.
